

TITLE/APPLICATION - 70

- (A) GENERAL
 - (1) THIS TARIFF SHALL APPLY TO CARRIAGE OF PASSENGERSAND BAGGAGE, INCLUDING ALL SERVICES INCIDENTALTHERETO, PERFORMED BY VS UNDER LOCAL AND JOINTRATES AND CHARGES.
 - (2) RULES APPLY TO LOCAL CARRIAGE VIA VS AND TO JOINTTRANSPORTATION VIA VS IN CONJUNCTION WITH OTHERPARTICIPATING CARRIERS.
 - (3) FARES AND CHARGES OR MONETARY AMOUNTS SHOWN INDOLLARS OR CENTS ARE STATED IN TERMS OF U.S.CURRENCY EXCEPT WHERE FARES AND CHARGES ORMONETARYAMOUNTS ARE SPECIFICALLY STATED AS BEINGPUBLISHED IN CANADIAN CURRENCY OR OTHER CURRENCY.
 - (4) RULES STATING ANY LIMITATION ON, OR CONDITIONS RELATING TO THE LIABILITY OF CARRIERS FOR PERSONAL INJURY OR DEATH ARE NOT PERMITTED TO BE INCLUDED IN TARIFFS FILED PURSUANT TO THE LAWS OF THE UNITED STATES, EXCEPT TO THE EXTENT PROVIDED IN RULE 55 (LIABILITY OF CARRIERS). NOTHING IN THIS TARIFF MODIFIES OR WAIVES ANY PROVISION OF THE WARSAW CONVENTION.
 - (5) RULES IN THIS TARIFF GOVERN THE APPLICATION OF ALLFARES AND CHARGES PUBLISHED INTARIFFS WHICHSPECIFICALLY REFER TO AND ARE MADE SUBJECT TO THISTARIFF WITH SUCH EXCEPTIONS AS MAY BE EXPRESSLYSTATED IN SUCH TARIFFS. THESE RULES CONSTITUTETHE CONDITIONS UPON WHICH EACH CARRIER TRANSPORTSOR AGREES TO TRANSPORT AND ARE EXPRESSLY AGREED TOBY THE PASSENGER TO THE SAME EXTENT AS IF SUCHRULES WERE INCLUDED AS CONDITIONS IN THE CONTRACTOF CARRIAGE.
 - (6) THE RATES, FARES, CHARGES, CLASSIFICATIONS, RULES, REGULATIONS, PRACTICES ANDSERVICES PROVIDEDHEREIN AND IN TARIFFS GOVERNED BY THIS TARIFF HAVEBEEN FILED IN EACH COUNTRY IN WHICH FILING IS REQUIRED BY TREATY, CONVENTION OR AGREEMENTENTERED INTO BETWEEN THAT COUNTRY AND CANADA, INACCORDANCE WITH THE PROVISIONS OF THE APPLICABLETREATY, CONVENTION OR AGREEMENT.
 - (7) EXCEPT AS OTHERWISE PROVIDED BELOW, FARE RULEPROVISIONS, LOCAL OR JOINT FARES, INCLUDINGARBITRATIES CONTAINED IN THE ON-LINE TARIFFDATABASE MAINTAINED BY AIRLINE TARIFF PUBLISHINGCOMPANY, AGENT ON BEHALF OF VS ARE CONSIDERED TOBE PART OF THIS TARIFF

(B) GRATUITOUS CARRIAGE
WITH RESPECT TO GRATUITOUS CARRIAGE, CARRIER RESERVESTHE RIGHT TO EXCLUDE THEAPPLICATION OF ALL OR PART OF THIS TARIFF.

- (C) CHANGE WITHOUT NOTICE

 EXCEPT AS MAY BE REQUIRED BYAPPLICABLE LAWS, GOVERNMENT REGULATIONS,

 ORDERSAND REQUIREMENTS, CARRIER'S RULES, REGULATIONS AND CONDITIONS OF

 CARRIAGE ARE SUBJECT TO CHANGEWITHOUT NOTICE; PROVIDED, THAT NO

 SUCHCHANGESHALL APPLY TO A CONTRACT OF CARRIAGE AFTER THEARRIAGE HAS

 COMMENCED.
- (D) WHEN RULES OR PROVISIONS IN THIS TARIFF OR TARIFFSGOVERNED HEREBY PROVIDE FOR THE APPLICATION OFFARES AND CHARGES BASED UPON PERCENTAGES OF OTHERFARES AND

CHARGES, SUCH PROPORTIONATE FARES ANDCHARGES WILL BE DETERMINED IN ACCORDANCE WITHTHEPERCENTAGE CONVERSION INSTRUCTIONS OF THIS TARIFF.

FARES IN EFFECT - 73

- (E) EFFECTIVE RULES, FARES AND CHARGES
 - (1) EXCEPT AS OTHERWISE PROVIDED HEREIN, THEAPPLICABLE RULES, FARES ANDCHARGES FORCARRIAGE OF PASSENGERS AND/OR BAGGAGE ARETHOSE DULY PUBLISHED BY VS ANDSHALL BE THOSEIN EFFECT ON THE DATE OF COMMENCEMENT OFCARRIAGE COVERED BY THE FIRSTFLIGHT COUPONOF THE TICKET. WHEN THE FARES OR CHARGESCOLLECTED ARE NOT THE APPLICABLE FARES ORCHARGES, THE DIFFERENCE WILL BE REFUNDED TO OR COLLECTED FROM THE PASSENGER, AS MAY BEAPPROPRIATE.
 - (2) (APPLICABLE ONLY TO SALE AND TICKETS ISSUEDIN THE U.S.A. FOR LOCAL AND JOINTTRANSPORTATION ORIGINATING IN THE U.S.A.)

 NO INCREASE WILL BE COLLECTED IN CASES WHERETHE TICKET HAS BEEN ISSUED PRIOR TO THEEFFECTIVE DATE OF A TARIFF CONTAINING ANINCREASE IN THE APPLICABLE FARE, EFFECTEDTHROUGH A CHANGE IN FARE LEVEL, A CHANGE INCONDITIONS GOVERNING THE FARE, OR CANCELLATION OF THE FARE ITSELF, PROVIDED:
 - (i) THE ORIGINATING FLIGHT COUPON OF THETICKET WAS ISSUED FOR A SPECIFIC FLIGHTAT THE FARE CONTAINED IN A TARIFF LAWFULLY IN EFFECT ON THE DATE OF TICKETISSUANCE (DETERMINED BY THE VALIDATIONON THE TICKET);
 - (ii) THE ORIGINATING FLIGHT SHOWN ON THETICKET IS NOT VOLUNTARILY CHANGED ATTHEPASSENGER'S REQUEST SUBSEQUENT TO THEEFFECTIVE DATE OF ANY INCREASE IN THEAPPLICABLE FARE:

 NOTE: THE PROVISIONS OF SUB-PARAGRAPH(i) AND (ii) ABOVE WILL NOT APPLY TOTICKETS ISSUED AT PUBLISHEDSTANDBY FARES.
 - (iii) THESE PROVISIONS SHALL APPLY ONLY TO THEPASSENGER TO WHOM THE TICKETWASORIGINALLY ISSUED. FURTHERMORE, THESEPROVISIONS WILL NOT APPLY TO SALES MADEOUTSIDE THE U.S.A. FOR TICKETS TO BEISSUED IN THE U.S.A.
